> ASSAGE CHRS LES CYTISES

The aim of the law dated April 13, 2016, was to combat violence against women. By strengthening the fight against commercial sex systems and helping prostitutes, this law has created a way out of prostitution into social and professional inclusion..

* Strengthen the fight against procuring,

- Improve the provision of care for the victims of prostitution, procuring, or the trafficking of human beings for the purpose of sexual exploitation,
- Promote a change in perspective with regards to prostitution by raising public awareness as well working on prevention with young people
- Help clients feel more responsible by enabling them to press charges against those who put women into prostitution.

What is **PSP** ??

After validation by a special commission presided over by the Préfet, a mutual commitment between the State and the victim will be established.

This commitment to finding a way out of prostitution will span over a two-year period including assessments and decisions taken by the Préfet every 6 months.

Who is eligible?

Anyone over 18 in a legal or illegal situation, a victim of prostitution who wants to get out of it.

What is the procedure?

First, contact us so that we can assess the situation and examine the feasibility of the case which will be put before the commission.

The person must commit to leaving prostitution.

The person can benefit from:

- ★ Financial aid amounting to €330,00 a month for a single person + € 102,00 per dependent child (on the condition that no other income is perceived)
- a protective residence permit including a work permit as soon as they are actively involved in and fully committed to the process.
- * easier access to housing and/or accommodation
- a range of protective benefits (social, administrative, legal, educational) either offered and/or coordinated by the CHRS les Cytises.
- * Free remission from tax debt.
